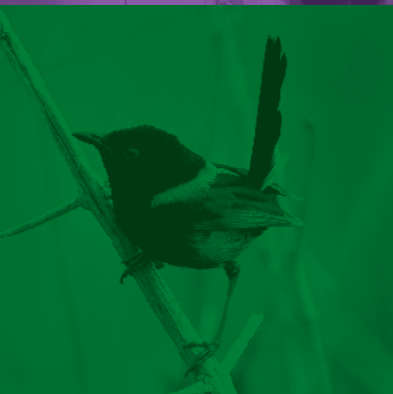
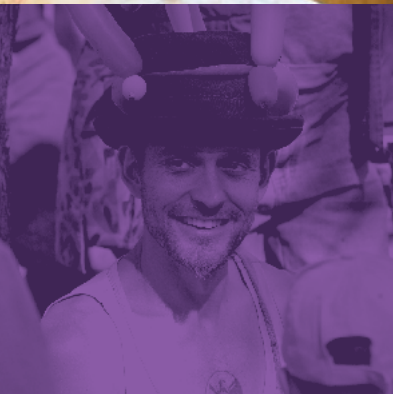

## CELEBRATE THE ARTS WITH ARTSTATE LISMORE!

A big event celebrating all that regional arts has to offer – Artstate Lismore – is coming to our city from 30 November to 3 December.

Artstate is a new four-year project by Regional Arts NSW to shine a light on excellence in regional arts practice. It will be held in a different regional location each year, kicking off with Lismore!

As part of Artstate Lismore there is a two-day conference with a program of high-profile speakers exploring the themes of creative practice and creative partnerships. Wrapping around this is an extraordinary arts program for the community to enjoy that showcases the very best in art, music and creativity that regional NSW has to offer.

Lots of the entertainment is free, some is ticketed, and there is a HUGE amount to choose from!

In the Lismore Quadrangle, come and be entertained by a spectacular opening ceremony featuring the Spaghetti Circus, the Cassettes and Northern Rivers Conservatorium Youth Jazz Orchestra, as well as a world-class First Nations ceremony curated by Bundjalung woman Rhoda Roberts AO. The Lismore Regional Gallery will be open late, and a free family and music program will then continue in the Lismore Quadrangle over the next four days.

Down at Lismore City Hall, catch NORPA's premiere of *Djurra*, the breathtaking new dance theatre work directed by Kirk Page and inspired by a Bundjalung creation story. Or if you're up for a bit of spark and sizzle, catch Brunswick Picture House's *Cheeky Cabaret* at the Star Court Theatre.

Artstate Lismore's conference keynote Soumik Datta will also be treating Lismore audiences to the Australian premiere of *Fretless Nomad*, a set played on the 19-stringed lute known as the 'sarod'. With Datta's musical collaborations including Beyoncé, Jay Z and the London Philharmonic Orchestra, this performance is sure to be intriguing.

# NEW LISMORE REGIONAL GALLERY NOW OPEN!

The new Lismore Regional Gallery off Keen Street is now open to the public and visitors and locals are invited to come and enjoy the new facility.

The new Lismore Regional Gallery was officially opened on Saturday, 28 October, in front of a huge crowd. The first exhibitions are now open to the public.

## ***Leora Siboney: Industrial Relations*** 29 October – 26 November 2017, Gallery 2 and 3

This exhibition is the artist's exploration of industrial structures in the landscape.

Living in the rural Australian landscape, Leora says she is often struck by the curious structures that punctuate the sparse open vistas and vast horizons.

She said questions arise about what functions these constructions perform. How are they designed? How and why are they built? What is their function?

*Industrial Relations* is a series of paintings that explore the purpose and function of these structures.

## ***Four Women: (I do Belong) Double*** 29 October – 10 December 2017, Gallery 1

In 1963 in southern USA, four young black girls were killed when the church they were in was firebombed. Some say Nina Simone wrote the song *Four Women* for the four women they may have become.

*Four Women (I do belong) Double* is curated by Djon Mundine and is inspired by that 1966 song *Four Women*, which speaks of the perception of black women and their inherent pain and strength.

The exhibition features the work of Karla Dickens, Fiona Foley, Romaine Moreton (in collaboration with Lou Bennett), Wart, Therese Ritchie (in collaboration with Jacky Green and Seán Kerins), Nasim Nasr, Teena McCarthy and Carolyn Strachan (in collaboration with Alessandro Cvadeni).

## ***Dreaming Trails*** 29 October – 3 December 2017, Gallery 2 and 3

Prior to European contact, Aboriginal communities had established a complex web of trade routes all over the continent. *Dreaming Trails* is a partnership between Yarrowarra Aboriginal Cultural Centre and Lismore Regional Gallery, and has been curated by Gumbaynggirr artist and curator, Alison Williams.

Working with Elders and visits to cultural sites, Williams has explored the notion of trade links between Bundjalung, Yaegl and Gumbaynggirr nations, with artists of these nations commissioned to create works based on historical objects from the collections of the Richmond River Historical Society and Yarrowarra telling the story of traditional trade.

The exhibition features the work of Kylie Caldwell, Jai Walker, Brentyn Lugnan, Kim Healey, Jeremy Mudjai Devitt, Frances Belle Parker and Digby Moran.

# FINAL WASTE TO ART WORKSHOP AND FREE COMMUNITY EVENT

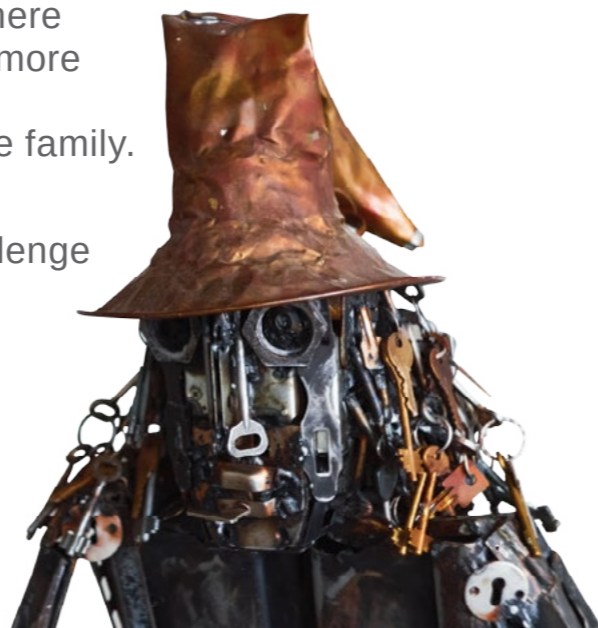
The final workshop in our Waste to Art Series is coming up at the end of November along with a free community event to celebrate National Recycling Week.

# LISMORE RIVER FESTIVAL AND CARP MUSTER



Saturday, 2 December, 10am to 4pm

**Come and join in the festivities to be in the running for over \$2000 worth of prizes at the inaugural Lismore River Festival and Carp Muster at Riverside Park.**

While carp are considered a pest, it is also the most eaten protein around the world. Did you know that locally caught carp are sold at the Sydney Fish Market?

This event will change your views on carp and we are encouraging a humane catch and kill approach using an ice slurry. Our *Love Food Hate Waste* chef Danial Lange will show you just how delicious carp can be with free carp recipe demonstrations and tastings.

Festival events and activities include fishing from the riverbank (BYO fishing gear), carp weigh-ins with prizes, carp filleting and cooking demonstrations and tastings, a tree planting, catchment health education and games, flood awareness, live music and talks from carp and river health experts.

Everyone is invited to come along, fishers and non-fishers alike, with plenty for everyone including the littlies with free children's activities.

Conservation Volunteers, Lismore City Council, Department of Primary Industries and OzFish are partnering for this event with additional support from the SES, Frogley's Offshore, Bunnings, Ballina Camping and Disposal, Richmond Landcare Inc., Rous County Council, Friends of the Lismore Rainforest Botanic Gardens, the Northern Rivers Science Hub and the Lismore Workers Club.

## GALLERY LAUNCHES CAMPAIGN TO KEEP HANNAH CABINET AT HOME

**At the grand opening of Lismore Regional Gallery on 28 October, a new campaign was launched to raise funds to purchase *The Hannah Cabinet* for the gallery's permanent collection.**

*The Hannah Cabinet*, which is currently on show at the gallery, was created by master craftsman Geoff Hannah, who works from a small workshop in the suburban back streets of Lismore.

Geoff is one of the finest cabinet-makers in the world and *The Hannah Cabinet*, first exhibited in Lismore in 2009, is still one of the most popular exhibitions in the gallery's history.

The wooden masterpiece stands 2.4 metres high and is estimated to be worth more than \$1 million. It was the result of 5000 hours of labour over a six-year period, and contains 34 Australian and international timbers and veneers, 17 types of stone, four species of shell, and 17 varieties of precious stone with extensive marquetry inlays. It has 18 doors and 140 drawers.

Lismore Regional Gallery Director Brett Adlington said it would be a coup for the cabinet to become part of Lismore's permanent collection and believes its rightful place is in the city Geoff calls home.

"A steering committee has been established to raise the funds – it may take some time, but we believe this would be an amazing acquisition and addition to a permanent collection that already holds more than 1000 pieces of fine art," Brett said.

"We will look outside the region and to generous donors as well as explore what grant funding we could apply for in order to raise the funds. It would be so appropriate to have *The Hannah Cabinet* in our permanent collection and it would also be a major drawcard to attract visitors.

"Geoff is so humble about his work, yet he is a true craftsman of the most extraordinary talent. We should celebrate that we have this renowned global artist in our midst and make a place for *The Hannah Cabinet* to be permanently on show in his hometown."

## ROAD RENAMINGS

### Proposed naming of new roads and renaming part of existing road – Back Creek Road, Bentley

The part of Back Creek Road to be renamed commences from the junction of Bucklands Bridge Road and continues south until the commencement of Kyogle Road. This part of the road is to be renamed due to confusion caused over the current road name format.

In preparation of renaming, Council wrote to the landowners affected along the road seeking proposed names. 'Moroney Road' was offered for consideration by several affected land owners.
